


1. stipulated by the affiliating University and/or

Our affiliating University i.e. Kurukshetra University, Kurukshetra grants extension of provisional affiliation to all the affiliated Colleges of Education from session to session basis every year. The University experts intensively inspect the college every year and ascertain that the college fulfills all the norms laid down by NCTE/Haryana Govt/University. **This high profile team** inspected **our college** this year also and awarded marking in a tight manner to determine standard of the college, even then our college obtained 75% & 76.6% marks in (1) Human Resource and (2) Physical & Academic Infrastructure and other Facilities & Amenities, respectively, **which shows excellence in over all merit** and the extension to the affiliation was granted for the session 2011-12 for B.Ed Course. Copy of the affiliation letter No. CG-VI/11/18844 dated 2-09-2011 is enclosed for perusal. The University has a set language, for all institutions i.e.:

"I am desired to inform you that extension in provisional affiliation has been granted to the aforesaid college to run B.Ed. (Regular) course for the session 2011-12, subject to the condition that the college is required to make up the deficiencies pointed out in the inspection report before the start of the regular classes."




6. In case the undertaking submitted by our institution found to be false then the accreditation given by NAAC is liable to be withdrawn.
